

USMCA CERTIFICATE OF RENEWAL: FREIGHT COURSE

Follow Frontier's step-by-step guide to ensure your 2025 Certificate of Origin is properly filled out:

FIELD 1 - CERTIFIER DETAILS

- Are you the importer, exporter or producer?
- Tells the reviewer who is filling out the form and how CBSA should contact you.

FIELD 3 - PRODUCER DETAILS

- You are the producer & certifier:
 You're only required to provide your
 company's name (since you've already
 given this info in field 2)
- There are multiple producers:
 Provide a list of the producers or simply state "various"
- A party who wishes to remain confidential:
 State "Available upon request by in

State "Available upon request by importing authorities"

If asked to disclose at a later date:
 the address of the producer should be the goods' place of production (needs to reside in a North American Country)

FIELD 6 - H.S TARIFF CLASSIFICATION

For each good described in Field 5:
 Identify the H.S tariff classification (H.S code) to the 6-digit level.

FIELD 2 - EXPORTER DETAILS

If you are the:

- Exporter & Certifier:
 You only have to include your or
 - You only have to include your company name
- Producer:

This info is not necessarily required as you may not know who the exporter is

• Importer:

This field needs to be filled completely. The address of the exporter will be the goods' location of export (residing in North America)

FIELD 4 - IMPORTER DETAILS

- You are the producer or exporter:
 and you know who the importer is, provide their: name, address, email & phone number
- Don't know who the importer: simply state "unknown"

FIELD 5 - DESCRIPTION OF GOODS

- For a single shipment of a good:
 Include the commercial invoice number. If unknown, indicate some other form of reference i.e. the shipping order number.
- For multiple goods:

Provide a *simple description* of each good with enough detail to relate it to an invoice description and its corresponding H.S code.

FIELD 7 - ORIGIN OF CRITERION

For your good to qualify for preferential tariff treatment it needs to meet at least one of the criteria given in the four categories below:

 A_{t}^{7}

The good was obtained or produced in the territory of 1 or more of the parties:

This good was made, grown or completely produced within North America.

B

Produced entirely in the territory of one or more of the Parties using non-originating materials:

This good was completely made within North America but it contains parts that are from a non-North American country.

C

Produced entirely in the territory of one or more of the parties exclusively from originating materials:

This good was manufactured entirely within North America using products that are from somewhere in either Canada, Mexico and/or USA.

D

Very specific to the production and entirety of the good. If your good does not fall under A, B, or C then contact our customs brokerage team to ensure it qualifies.

FIELD 8 - COUNTRY OF ORIGIN

 Identify the country of origin of the good: CA, US, or MX

FIELD 9 - BLANKETED PERIOD

 For multiple shipments of identical goods:
 The certification will cover these shipments for a specified period of up to 12 months

FIELD 10: I CERTIFY THAT:

 The certification must be signed and dated by the certifier and accompanied by the following statement:

"I certify that the goods described in this document qualify as originating and the information contained in this document is true and accurate. I assume responsibility for proving such representations and agree to maintain and present upon request or to make available during a verification visit, documentation necessary to support this certification."
